Representative Trials

- Tried to a favorable verdict the removal of general partners on two affiliated LIHTC properties where the general partners and their affiliated property manager "loaned" money from the partnerships for their own uses over the course of several years. Following trial, in a 34-page opinion, the Court enforced the clients' rights to remove the general partners, required termination of the property manager, rejected the claims of the general partners' attorneys regarding "aggregator misconduct," and required transfer of control of the property to the investor's representatives within 30 days. - After trial, obtained dismissal of a bankruptcy filed by a general partner attempting to gain leverage in buy-out negotiations with the manager of limited partner interests in a portfolio of LIHTC partnerships valued at more than \$100 million. (Read more.)
- Engaged by a sitting judge and his former law partner to pursue a fee dispute against an attorney formerly associated with their firm, who took cases from the firm when he departed. Following an eight-day trial, obtained judgment in excess of \$1.1 million (the full demand) in favor of our clients, which was more than four times the pre-trial offer of settlement from the defendant. Business Litigation

- Defended a RICO claim and related business torts seeking in excess of \$200 million in damages; based on motion practice, and in exchange for withdrawing pending sanctions motions against the plaintiff, the client was voluntarily dismissed from the suit without payment.

Injunction
