In that role, he worked with companies to comply with environmental regulations through the use of best management practices for water pollution.

Representative Matters

- Won a motion to dismiss on behalf of a state bank in a putative class action lawsuit arising out of the bank's assessment of non-sufficient funds fees. Subsequently settled the case on favorable terms.
- Prevailed in the U.S. Court of Appeals for the Fifth Circuit, which upheld a district court's ruling in favor of our banking client regarding a claim brought under the Equal Credit Opportunity Act related to the Small Business Administration's Paycheck Protection Program.
- Successfully defended the former CEO and current executive chairperson of a publicly traded
 Fortune 500 company in a lawsuit brought by a shareholder seeking to recover more than \$1 million
 in alleged short-swing profits under Section 16(b) of the Securities Exchange Act. Won on a motion
 for summary judgment by arguing that the stock sales were exempt transactions that only changed
 the form of beneficial ownership without altering the pecuniary interest in the stock.
