She has served in many leadership roles at Baker Donelson, founding its Long Term Care Group, chairing the Health Care Litigation Group and Baker Women, and serving on the Firm's board of directors.

Christy has successfully tried cases in many venues including state trial court, before the Tennessee Department of Health, before numerous arbitrators, and before the governing body of the United Network of Organ Sharing. As an experienced appellate attorney, Christy has presented oral arguments before the Tennessee Supreme Court and Tennessee Court of Appeals. She serves as an arbitrator and is certified by the American Arbitration Association (AAA). Christy concentrates her practice in health care litigation, managing the litigation of numerous health care facilities around the country, as well as serving as outside general counsel.

Christy provides counsel to health care companies on quality assurance, corporate compliance, general business advice and litigation avoidance challenging survey citations, and government investigations. She represents many health care related organizations, including organ procurement organizations and tissue banks, long term care providers, onsite health centers, and one of the largest behavioral health companies in the country.

Christy has been recognized by *Chambers USA* as a leading Litigation: Medical Malpractice Defense lawyer in Tennessee for five consecutive years and is one of only six attorneys in the state of Tennessee listed in Band 1. Representative Matters

- In 2024, obtained a full defense judgment in an arbitration for a continuing care retirement community (CCRC) for claims brought based on the challenges to the CCRC contractual model.
