### Representative Matters

- Represented the unsecured creditors committee in the Knight Energy Holdings bankruptcy proceeding involving more than \$250 million in defaulted debt. Negotiated with the debtor, old equity and the secured lender to secure 2.5 times the initial offer made to the unsecured creditors.
- Represented an oil and gas exploration company, which was also a debtor-in-possession, in a Chapter 11 bankruptcy proceeding. In under six months, the debtor was able to confirm a consensual plan that converted its debt to equity, and the debtor emerged as an operating entity. The matter represents one of the few instances in which an oil and gas exploration company successfully confirmed a restructuring plan in a tightened economic climate.
- Obtained dismissal, with prejudice, of all claims against an insurance broker in a contentious preference litigation brought by the trustee in a bankruptcy matter.
- Represented the Chapter 11 trustee and plan administrator for two real property holding companies. Negotiated a global settlement with the trustees of two related Chapter 7 debtors and all creditors.
- Defended a large national insurance broker against a \$900,000 preference demand in the bankruptcy case of a major offshore marine company. Settled the demand on favorable terms.
- Prevailed in the U.S. Court of Appeals for the Fifth Circuit, which upheld a district court's ruling in favor of our banking client regarding a claim brought under the Equal Credit Opportunity Act related to the Small Business Administration's Paycheck Protection Program.
- Represented a heavy equipment financing corporation with a secured claim of \$4.9 million in the Chapter 11 bankruptcy action of a construction company. Successfully negotiated favorable treatment under the bankruptcy plan, which contained a large initial lump sum payment and preserved the corporation's right to pursue the guarantors.

- Represented the holder of a \$10 million secured loan in the Chapter 11 bankruptcy case of a major metropolitan trash company. Negotiated a favorable settlement.
