- Following oral argument to the Georgia Supreme Court, obtained a published decision affirming a trial court's final judgment cancelling an arguably superior interest in real property held by a competing lender.
- Obtained a directed verdict at trial on behalf of a Fortune 500 bank in a lawsuit alleging violations of the Electronic Funds Transfer Act based on purportedly unauthorized debits and ATM withdrawals.
