At HHS, he was responsible for litigating actions imposing civil money penalties and assessments, as well as suspensions from Medicare and Medicaid participation, based on violations of the Medicare and Medicaid fraud and abuse statutes. In that role, he was extensively involved in issues arising under the anti-kickback provisions of the Social Security Act and in the drafting and passage of the Medicare and Medicaid Patient and Program Protection Act of 1987.

Mr. Holden is the immediate past president and a former member of the Board of Directors of the American Health Law Association. He served on Baker Donelson's Board of Directors from 2017 to 2023. Mr. Holden is a frequent lecturer and author on Medicare and Medicaid fraud, abuse and reimbursement issues.
