Elizabeth Haskins represents clients in environmental and energy litigation, regulation, and compliance matters before federal, state, and administrative courts and commissions. Her experience includes representing clients in matters involving a range of environmental, health and safety (EHS) issues, including National Environmental Policy Act (NEPA) and National Historic Preservation Act (NHPA) compliance, Clean Water Act issues, contaminants of emerging concern (CECs) and PFAS issues, Occupational Safety and Health Administration (OSHA) compliance, and California Proposition 65 claims. Ms. Haskins also provides environmental due diligence on real estate transactional matters, including brownfield developments.

Ms. Haskins helps companies manage their environmental risk and identify environmental, social, and corporate governance (ESG) opportunities.

She represents clients in the energy industry on regulatory and compliance issues and advocates for clients in front of the Federal Energy Regulatory Commission (FERC) and state utility commissions. Ms. Haskins counsels clients across industry sectors, including electric vehicles and energy infrastructure, on project development, as well as permitting and regulatory approvals and land use advice, and on negotiating precedent, service, and rate agreements.

Ms. Haskins previously served as a trial attorney for the Department of Justice's Civil Division, Federal Programs Branch, where she defended federal agencies in matters concerning employment discrimination, the Affordable Care Act, tribal contracting, and administrative law.
