Representative Matters

- Successfully defended a national pharmaceutical retail chain in an ADA discrimination claim brought in U.S. District Court. Won summary judgment on all counts by successfully arguing the employee did not meet the definition of a "qualified individual" under the Act, and secured confirmation of judgment on appeal before the United States Court of Appeals for the Fourth Circuit.
- Obtained summary judgment on behalf of a Maryland municipality in a complex wage and hour matter brought under the Fair Labor Standards Act, Maryland Wage and Hour Law, and Maryland Wage Payment and Collection Law.
- Served as first chair in defense of a large healthcare system in a wrongful termination and breach of contract action brought by a physician. Ultimately obtained judgment in favor of the health system on all counts.
- Successfully defended a Maryland construction company in a wage and hour matter brought under the Fair Labor Standards Act and Maryland Wage and Hour Law by obtaining summary judgment under the Portal-to-Portal Act and the Motor Carrier Exemption to the FLSA.
